CONAFI PRESTITÒ commences buy back programme

In accordance with the share buy-back programme authorised by the Shareholders' Meeting of April 29, 2009, extended by the Shareholders' Meeting of April 29, 2009, Conafi Prestitò hereby discloses that in the period between March 03 and March 05, 2010, it purchased on the MTA Market – through Banca Intermobiliare di gestioni ed investimenti S.p.A., appointed to carry out the buy-back programme – a total of 20.000 Conafi Prestitò ordinary shares (approx. 0,04301% of the share capital) for a total value of Euro 20.135,21.

A summary of the share purchases made in the period is shown in the table below:
