CONAFI PRESTITÒ commences buy back programme

In accordance with the share buy-back programme authorised by the Shareholders' Meeting of April 30th, 2010, approved by the Board of Directors on May 13th, 2010 Conafi Prestitò hereby discloses that in the period between November 16th and November, 19th 2010, it purchased on the MTA Market – through Banca Intermobiliare di gestioni ed investimenti S.p.A., appointed to carry out the buy-back programme – a total of 45.000 Conafi Prestitò ordinary shares (approx. 0,096774% of the share capital) for a total value of Euro 94.252,02.

A summary of the share purchases made in the period is shown in the table below:
