## **CONAFI PRESTITÒ commences buy back programme**

**Turin, September 29th 2008**

In accordance with the share buy-back programme authorised by the Shareholders' Meeting of October 23th, 2007, approved by the Board of Directors on November 7th, 2007 and extended by the Board of Director of April 29th, 2008, Conafi Prestitò hereby discloses that in the period between September 22th and September 26th, 2008, it purchased on the Expandi Market – through Banca Intermobiliare di Gestioni ed Investimenti S.p.A., appointed to carry out the buy-back programme – a total of 22.500 Conafi Prestitò ordinary shares (approx. 0,04839% of the share capital) for a total value of Euro 35.793,18.

A summary of the share purchases made in the period is shown in the table below:

[The share purchases were made on the Expandi Market, pursuant to the provisions of article 2357 of the Civil Code, article 132 of Legislative Decree No. 58/98 and article 144-bis of Consob Regulation No. 11971/99 (as subsequently modified), and within the limits and objectives set out in the Shareholders' and Board of Directors' meetings authorising the buy-back programme. The purchases were also made within a daily limit of not greater than 25% of the average daily volume of Conafi Prestitò shares traded on the market, in accordance with article 5 of EU Regulation No. 2273/2003]
